Pursuant to this agreement and in consideration of the due diligence exercised by the staff, I hold Rex's Playhouse Facility harmless for any liability with respect to loss or damage resulting from disease, theft, fire, death, escape, or injury to my dog(s).
- 3) Standard precautions will be used against injury, escape or death. Rex's Playhouse Facility will not be held responsible for injuries that occur, provided standard care and precautions have been followed as determined at the sole discretion of Rex's Playhouse Facility.

- 7) I understand that I must provide veterinary proof of such vaccination both before my dog's first visit at the facility, and periodically as required when vaccinations are updated.
- 8) I hereby agree to maintain my dog(s) scheduled heartworm and flea preventative as appropriate, or when requested by Rex's Playhouse. I will be responsible for any costs incurred for any such treatment if required.
